2021 Annual Meeting
Tuesday April 20, 2021
7:00 PM

Harry called the annual meeting to order at 7:00 p.m. Board members present were Harry Warden, Dan Whitehead, and Susan Huftel.

Minutes from the Annual Meeting on September 15, 2020 were read. Dan Whitehead made the motion to accept the minutes as read and Jason Wiley seconded the motion. Voice vote was taken all in favor.

Minutes from the May 18, 2020 Board of Review were read. Harry Warden made the motion to accept the minutes, Susan Huftel seconded the motion. Voice vote was taken all in favor.

Minutes from the November 9, 2020 Public Budget Hearing Meeting, Special Town Meeting of the Electors and Special Town Board Meeting were read. Lisa made the motion to accept the minutes as read and Jon seconded the motion. Voice vote was taken all in favor.

Public issues were discussed.

Dennis Norrish asked how much it was to have the county collect the taxes. Harry stated that the cost of having them do it was subtracted from the treasures salary so it was not any additional cost to the town.

The Annual Report was looked over and reviewed. Jason Wiley made the motion to accept the report as printed and Dennis Norrish seconded the motion. Voice vote was taken all in favor.

Fire Department stated that they would like to recruit some new fire fighters. If anyone is interested contact Jason Wiley, the fire chief or reach out to a board member and they can point you in the right direction. Currently there are 6-8 active members. Would like at least 12. Dispatching will now go through Dunn Co. so will have to go back to using the 911 number for emergencies.

Dunn County will now be handling the burning permits as well.
Fire Department Purchased a Cordless Jaws of life.

Bridge repair is scheduled to start in mid-May. Thursday will be a pre constructions meeting via call in. Harry plans to do so,.

Jason Wiley and Dennis Norrish would like to be notified of the bridges/road closure date. Jason will let the surrounding fire and EMS know of the road closure.

Solid Waste fee covers the cost of hauling and paying workers but the startup costs of \$30,000.00 invested is as a capital purchase of equipment and an additional \$5,000.00 for installation costs. (New compactor & Pad and electrical)

Spring Brook and Peru townships are allowed to purchase stickers to use the facilities.

Dennis stated that a list compiled by the treasurer of what people pay for taxes in our township to be sent along with the tax bills was voted by the electors at an annual meeting. He asked why this is not being compiled. Harry explained that this was an advisory motion and that the board would take it into consideration. Harry explained that this was not an easy list to compile and it is available on line through the GIS (Dunn County) web site. Sue has asked the county if they could send it as an electronic file and they said that they cannot. Chuck made motion to have the numbers compiled and sent with the tax bill. Dennis seconded. Hand vote was taken. Five in favor, four opposed and one abstained. Harry will bring it before the board and make a decision.

Chuck asked if there was a paper that the entire township had access to so town meetings could be posted there or maybe use postcards. Harry stated that there was not. Sue said for postcards that went out it cost \$231.00.

Currently meetings are posted at the town hall in the display case, at Luers in Carryville and on the town's webpage.

The date for the next Annual Meeting was set for Tuesday, April 19, 2022 at 7:00 P.M.

Motion to adjourn was made by Sue Huftel at 8:10 P.M. and seconded by Jon Koller, vote taken all in favor.
