

Monthly Town Board Meeting Minutes
Wednesday, February 18, 2026
Rock Creek Town Hall
7:00 PM

1. Rachel called the meeting to order at 7:00 P.M. Board members present were Rachel Kummer, Jon Koller, and Kelly Boardman. Dylan Panette, and Jason Wiley also attended.
2. Jon made a motion to approve the January monthly meeting minutes. Rachel seconded the motion. Vote taken, two in favor, zero opposed and zero abstained.
3. Rachel made a motion to approve the December treasurer's report. Jon seconded. Vote was taken, two in favor and zero opposed, zero abstained.
4. Rachel made a motion to approve the financial report for December. Jon seconded. Vote taken, two in favor, zero opposed and zero abstained.
5. Jon made a motion to provisionally approve the treasurers' report for January. Rachel seconded. Vote was taken, two were in favor and zero opposed and zero abstained.
6. Jon made a motion to provisionally accept the Financial Report for January Rachel seconded. Vote taken, all in favor and zero opposed and zero abstained.
7. Report from the Chair:
 - Bridge on Cty Road H is scheduled to be repaired in 2027.
 - Highway 85 from the Coffee shop/Feed Mill in Rock falls to the Eau Claire County line.
 - Award of Damages. Rachel is thinking this is for a right of way. She is looking into it.
 - Rachel will submit the water usage report soon.
 - EMS Grant. Not sure if the town should join. Jon and Jason will follow it and advise.
 - Dunn County Highway is implementing additional admin fee.
8. Jon made a motion to post road bids for 110th Ave. Bid to be in ½, ¾ and 1 mile increments. Rachel seconded. Two in favor, zero opposed and zero abstained.
9. Jon made motion to contract with KBIS to conduct bridge inspections on 90th ave over Coon Creek and 150th Ave/Huftel Hill. Rachel seconded. Two in favor, zero opposed and zero abstained.
10. The updated Solid Waste Ordinance O2020-10-15 (Rev 2026-03-18) was looked over. It will be reviewed again on March 18, 2026. The board will then vote to adopt the revised ordinance.
11. Jon made a motion to grant Rock Falls Raceway a Class "B" Alcohol license for Feb 19, 2026 to June 30, 2026. Rachel seconded the motion. Vote was taken, two were in favor and zero opposed and zero abstained.

Jon made a motion to grant Travis Hilton an operator's license for February 19, 2026 to June 30, 2026. Rachel seconded. Two in favor, zero opposed and zero abstained.

Jon made a motion to grant Rock Falls Raceway a Class "B" Alcohol license for July 1, 2026 to June 30, 2027. Rachel seconded the motion. Vote was taken, two were in favor and zero opposed and zero abstained.

Jon made a motion to grant Travis Hilton an operator's license for July 1, 2026 to June 30, 2027. Rachel seconded. Two in favor, zero opposed and zero abstained.

12. Public Comments:

- Rachel will look into putting a permanent wait limit sign on Heffernan Hill.
- Culverts are needed by Conrads near the Amish farm, one by Rachel Kummer's on 810th St.
- Road damages near Fossum's cabin and Billy's
