1. Rachel called the meeting to order at 7:00 P.M.

- 2. Rachel made a motion to approve the July monthly meeting minutes as amended. Jon seconded the motion. Vote taken, three in favor, zero opposed and zero abstained.
- 3. Adam made a motion to approve the June treasurer's report. Jon seconded. All in favor and zero opposed, zero abstained.
- 4. Jon made a motion to approve the financial report for June. Adam seconded. Vote taken, all in favor, zero opposed and zero abstained.
- 5. Adam made a motion to provisionally approve the treasurers' report for July. Jon seconded. Vote was taken, all were in favor and zero opposed.
- 6. Jon made a motion to provisionally accept the Financial Report for July. Adam seconded. Vote taken, all in favor and zero opposed.
- 7. Report from the Chair:
 - Rachel attended the County Unit Meeting, Delmore can inventory the signs and culverts.
 - Emergency Code Red is Pushing everyone to sign up
 - Town Dues were \$25.00 now \$50.00.
 - Innovation grant will be discussed at the October 22, 2025 banquet.
 - Rachel is now on the LRIP Committee
 - Fuller Road had Pot holes fixed and 3 loads of Rock added.
 - Small gun range must be at lest 100 yards from any house.
 - The construction trailer that was at the town hall will make a payment at year end.
 - LRIP training is available online.
 - Town will need documentation and affidavit from paper and bids ready to submit for \$14,000.00 on 810th St and \$15,000.00 on 110th to Hwy 85 and 850th from 110th to Hwy 85. We have till 2029.

8. Public Comments:

- Brush by Hayden's on Huftel Hill near the bridge need to be trimmed back.
- 9. Board discussed abandoning 939th St.
 - 1. Option one would be to abandon the whole road
 - 2. Option two could be to abandon the cemetery end. Cemetery owns property and are not interested.
 - 3. Option three would be to abandon Kris Komor's end of the road.
 - After discussion it was decided that it was not feasible to abandon any portion of the road.

10. Road Updates:

- 850th Street was shouldered.
- Philbin Road possible work would be to grade the end and add base coarse from the DNR Entrance to the end of the road.
- Several roads have grass growing in the cracks. Town will take care of this.
- 11. Morgane discussed options to have solid waste placed on the tax roll. Rachel is researching this and waiting on a response.
- 12. Jon made a motion to grant Krista Mehling and Melissa Nelson operator's license for the fishing contest, And a Picnic license to the Rock Falls Sportsman's Club on September 6, 2025. Adam seconded. All in favor and zero opposed.
- 13. Door locks on the town hall and fire station were discussed. WWT will have monitored locks for \$15.00 per month plus install of \$250.00 per door. These are wireless and have a battery life of one year.

Jon made a motion to contact will WWT for 4 security door locks to be placed on the town hall and the Fire Department doors. Adam seconded. All in favor and zero opposed.

- 14. Driveway and Building Permit.
 - Behm's driveway and building permit have been approved.
- 15. Plan Commission: Update by Al
 - Signs were placed during the 4th of July saying a survey is coming.
 - Commission is working on a cover letter and the survey.
- 16. Fire Department: update by Jason
 - Jason stated that they responded to a car accident, a motorcycle accident, and a structure fire.
 - Vacuum system update on the engine.
 - Sold the squad truck for \$2,575.00.
- 17. Park Commission: update by Roy
 - Park is looking into fencing the back side of the park
 - The County did a traffic study and they are not willing to lower the speed limit by the park at this time.
- 18. Bills were reviewed, authorized, and paid.
- 19. Next Town Board meeting will be Tuesday, September 16, 2025 at 7:00 PM at the town hall.
- 20. Motion to adjourn was made by Jon and seconded by Adam, vote taken all in favor.
