Click on "I accept" for the disclaimer. The next screen will come up. On this screen, less is more. Just enter in a last name OR a house number OR a parcel number so it can do a broad search.

Click on the appropriate tab to search for Land Records data. The Parcel Tab allows you to search for Parcel Records and the Permit Tab for Permits. Next, enter your search criteria and click
